As per Government of Punjab, Department of Higher Education (Education Branch) Notification No. 14/8/2011-3Edu1/1019335/1 dated 10.7.2017, Panjab University Chandigarh has been entrusted with the responsibility to conduct common Entrance Test (C.E.T.) for admission to B.Ed. course in the Colleges of Education (Govt., Govt. Aided, Private Self financed Colleges) affiliated to Panjab University Chandigarh, Punjabi University Patiala, and Guru Nanak Dev University, Amritsar.

The Hon'ble High Court of Punjab & Haryana in CWP 20036 of 2017 titled Sadbhavna College of Education for women vs Panjab University & others (along with CWP Nos. 20329,20435,20760 & 21158 of 2017 (O&M) has given the directions to State Government on 09.10.2017 to evolve a methodology to make available sufficient candidates in order of merit to fill up the remaining seats either by holding another Common Entrance Test or by inviting applications directly from the candidates and then prepare their merit list as per their academic performance and allocate the students to the colleges before 31.10.2017.

In compliance of the orders of the Hon'ble High Court of Punjab & Haryana, Government of Punjab hereby authorizes the Panjab University, Chandigarh to conduct another Common Entrance Test to fill up the remaining seats and allocate the students to the colleges before 31.10.2017.

All other conditions as mentioned in the notification no. 14/18/2017-3Edu1/1019335/1 dated 10/7/2017 shall remain same.


